**LEGAL QUALIFICATIONS**

Candidates filing a nominating petition for Board membership must meet the following qualifications:

- He/She is a citizen of the United States of America
- He/She must be at least 18 (eighteen) years of age.
- He/She must be able to read and write.
- He/She has been a resident of the municipality from which he/she is to be elected for at least one year preceding the date of the election.
- He/She is not disqualified as a voter pursuant to R.S.19:4-1.
- He/She is a registered voter in the district.

*No Board of Education member shall be directly or indirectly involved in any contract with, or claim against the Board.*

Completed nominating petitions shall be filed with the Secretary of the Board on or before 4:00 p.m. of the fiftieth day preceding the date of the election, or **Monday, February 28, 2005**. The office of the Board Secretary is located in the Administration Building of the Woodbridge Township School District, School Street, Woodbridge, and the days, dates, and business hours during which the office is open to receive petitions are: **8:30 a.m. to 4:00 p.m., Monday through Friday, excluding school holidays as follows: Friday, February 18, 2005 and Monday, February 21, 2005.**

The last day for a candidate to withdraw his/her name is on or before 4:00 p.m., Monday, March 7, 2005.

Drawing for ballot positions will take place at the Administration Building, School Street, Woodbridge, in Conference Room A on Wednesday, March 9, 2005, at 4:30 p.m.
